While these doctrines may come up in class discussion, be referred to by a chapel speaker, or be briefly replied to by a teacher, it is not the intent of Coulee Christian School to engage in protracted teaching upon these topics unless all viewpoints are presented without partiality. Teachers, the Administrator, and staff are requested to refer these four doctrinal items to the home and or church.
